## ARTICLES OF INCORPORATION OF HOME PLUS MIAMI, INC.

The undersigned, acting as incorporator of HOME PLUS MIAMI, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

#### ARTICLE I. NAME

The name of the corporation is HOME PLUS MIAMI, INC. (the "Corporation").
