## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF EAGLE METAL PROCESSING & RECYCLING, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, EAGLE METAL PROCESSING & RECYCLING, INC., a Florida corporation (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The Articles of Incorporation of the Company were filed on April 18, 2012 and assigned document number P12000036974.

SECOND: Article I of the Company's Articles of Incorporation is hereby amended in its entirety to read as follows:

## "ARTICLE I.

The name of the corporation shall be Eagle Scrap Yard, Inc."

THIRD: Except as expressly provided herein, all of the terms an provisions of the Articles> of Incorporation shall remain in full force and effect and are hereby ratified and confirmed.

FOURTH: The effective date shall be the date these Articles of Amendment to the Articles of Incorporation are approved by the Florida Secretary of State.

FIFTH: The foregoing amendment was adopted by written consent of the sole shareholder on October 25, 2021, in accordance with the provisions of the Florida Business Corporation Act.

SIXTH: The number of votes cast for the amendment by the sole shareholder was sufficient for the approval thereof.
