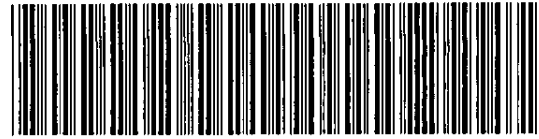

The undersigned, acting as an Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - Name

The name of the corporation is: **DiyaAryan Holdings, Inc.**

ARTICLE II - Principal Office and Mailing Address

The mailing address of the initial principal office is: 4958 Peregrine Point Way, Sarasota, Florida 34231.

ARTICLE III - Shares
