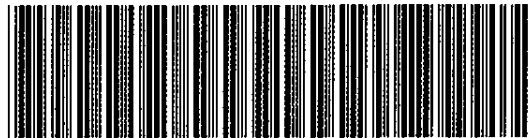

ARTICLES OF INCORPORATION
OF
SUNRISE ASSISTED LIVING FACILITY, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME: The name of the corporation shall be SUNRISE ASSISTED LIVING FACILITY, INC.

ARTICLE TWO: DURATION: The term of existence of the corporation is perpetual.

ARTICLE THREE: PURPOSE: The purpose is to engage in any activities or business permitted under the Laws of the United States and Florida; including but not limited to, the operation of a twenty-four hour live-in, private home care facility for sick and elderly people.

ARTICLE FOUR: CAPITAL STOCK: The corporation is authorized to issue one hundred (100) shares, all of which shall be common shares, no par value.




Pursuant to Chapters 48.091 and 607.0501, Florida Statutes, the following is submitted:
