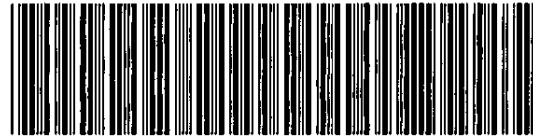

FOR
AMERICAN WORDATA, INC.**

The undersigned, for the purposes of forming a corporation under the Florida Business Corporation Act, F.S. Chapter 607, hereby make, acknowledge and file the following Articles of Incorporation.

ARTICLE I - NAME.

The name of the corporation shall be American Wordata, Inc. ("Company").

ARTICLE II - ADDRESS.

The mailing address and street address of the principal place of business of the Company in Florida shall be:

ARTICLE III - DURATION.

The Company shall commence its existence on the date these Articles of Incorporation are filed with the Florida Department of State. The Company's existence shall be perpetual.

ARTICLE IV - PURPOSES AND POWERS.

The general purpose for which the Company is organized is to conduct and to transact any lawful business for which a corporation may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a corporation under the laws of the State of Florida.

ARTICLE V - STOCK.

The Company shall have the authority to issue 1,000 shares of no par value class C common stock. Any unissued shares of stock may be issued from time to time by the Company in such manner, amounts, and proportions as may be determined from time to time by the Board of Directors to the extent permitted by these Articles and by law.

Prior to the issuance or sale by the Company of any shares of stock, such stock shall first be offered, on the same terms of the proposed issuance or sale, to the then existing holders of the Company's class C common stock in proportion to their respective holdings.

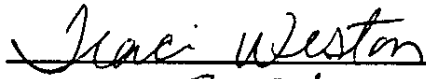
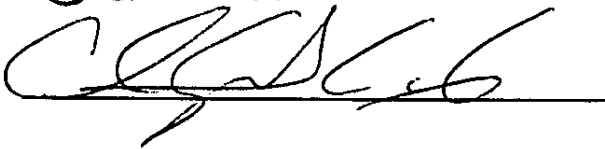

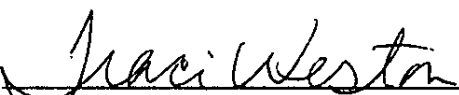
