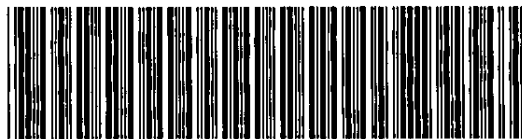

Section A of Article IV of the Amended and Restated Articles of Incorporation of the  
corporation is hereby amended to read in its entirety as follows:

**ARTICLE IV**

A. Authorization. The aggregate number of shares of all classes of stock which the  
Corporation shall have authority to issue is 217,912,172, such shares being designated  
as follows: (i) 175,000,000 shares of common stock, no par value (the "Common Stock")  
and (ii) 42,912,172 shares of preferred stock, par value \$0.001 per share (the "Preferred  
Stock") 42,912,172 shares of which are designated Series A Convertible Preferred Stock  
(the "Series A Preferred Stock"). The Common Stock and the Series A Preferred Stock  
shall have the following designations, preferences, rights, qualifications, limitations and  
restrictions set forth in Section B and C, respectively of this Article IV. The Preferred  
Stock no otherwise designated as Series A Preferred Stock may be issued from time to  
time in one or more classes or series


