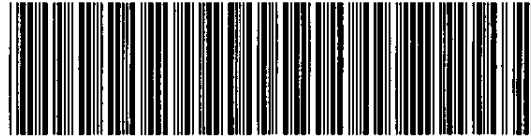

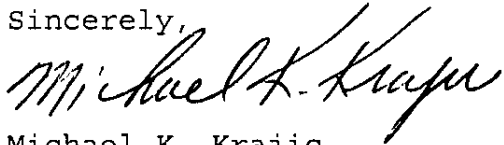

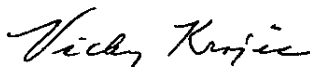

ARTICLE I. NAME

The name of this corporation is 1205 ENTERPRISES, INC.
