- (a) engage in any business or activity other than the ownership of its equity interest in Huntington Green of Melbourne, LLC ("Borrower") who will obtain financing (the "Loan") as evidenced by a Promissory Note executed by the Borrower and made payable to Barclays Bank PLC, a public company registered in England and Wales (together with its successors and assigns, "Lender") and a Loan Agreement entered by the Borrower and Lender (as amended, the "Loan Agreement") and secured by the lien on the Properties evidenced by a Renewal, Amended and Restated Mortgage, Assignment of Leases and Rents, Security Agreement and Fixture Filing filed in the official public records of Brevard County, Florida for the benefit of Lender (the "Security Instrument), and activities incidental thereto;
 - (b) acquire or own any material asset other than its equity interest in Borrower;;
