ARTICLES OF INCORPORATION OF PATAGONIA SEAFARMS, INC.

The undersigned, acting as incorporator of Patagonia SeaFarms, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is Patagonia SeaFarms, Inc. (the "Corporation").
