ARTICLES OF INCORPORATION  
OF  
AUTHENTIC POWER SYSTEMS, INC.

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

The name of the Corporation is: AUTHENTIC POWER SYSTEMS, INC.

ARTICLE II

This Corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III

The Corporation is organized to conduct lectures, seminars and workshops on a variety of miscellaneous topics.

ARTICLE VII

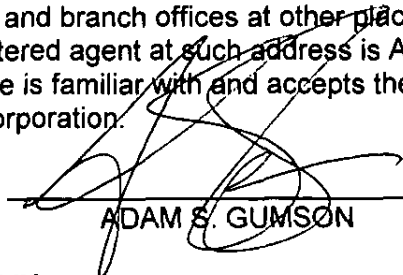

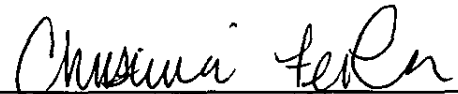
