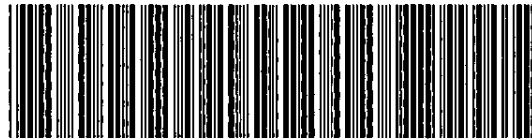



ARTICLE I. NAME AND ADDRESS. The name of this corporation shall be

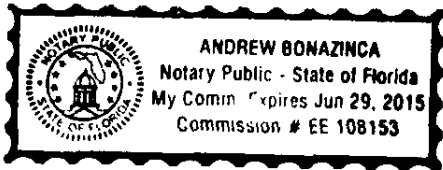
