The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name is this corporation is:

ECQ ELECTRONICS, INC

ARTICLE II - NATURE OF CORPORATE BUSINESS

The general nature of the business to be transacted by this corporation is as follows:

- (a) To operate a business to advertise, purchase and sell all types of tangible products and the engaging in, of any other business incidental and pertinent thereto.
- (b) To manufacture, sell, make, distribute and handle in any way that may be deemed to be the best interest of the corporation, any merchandise or byproduct that may be used in the making, or may be the result of the making or manufacturing of the product in connection with the business

operated by this corporation, or as a result of exploitation of any patent rights of whatever nature that may be acquired by this corporation.

- (c) To acquire by purchase, subscription or otherwise and to hold for the purpose of investment or otherwise, and to own, sell or otherwise dispose of and deal in stocks, bonds, mortgages, securities, notes, commercial papers, or otherwise deal with other evidence of debt, issued by any government, state, country or other public authority, or by any one or more persons, firms, corporations, or associations, either foreign or domestic, and whether now or hereafter organized, and while the owner thereof, to execute all of the rights, powers and privileges of ownership; to guarantee or become surety with respect to any obligations of said persons, firms, corporations or associations contained in any said securities.
- (d) To purchase real estate and to build upon or in any manner improve any real-estate owned by it.
- (e) To purchase, acquire, hold, sell, convey, mortgage, lease, exchange and otherwise deal in real estate and personal property of any kind, nature and description whatsoever.
- (f) To buy, sell, trade or deal in any kind of goods, services, wares and merchandise.
 - (g) To organize or cause to be organized under the laws of the State of
