The undersigned, desiring to form a professional corporation under the provisions of Chapters 607 and 621 of the Florida Statutes, as amended, sets forth the following:

ARTICLE I

NAME

The name of the corporation shall be: **DAVID CHRISTIAN**, **D.D.S.**, **P.A.** (hereafter, the "Corporation").

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation shall be 2902 59th Street West, Suite H, Bradenton, Florida 34209.
