**ARTICLES OF INCORPORATION
OF
DAVID CHRISTIAN, D.D.S., P.A.**

The undersigned, desiring to form a professional corporation under the provisions of Chapters 607 and 621 of the Florida Statutes, as amended, sets forth the following:

ARTICLE I

NAME

The name of the corporation shall be: **DAVID CHRISTIAN, D.D.S., P.A.** (hereafter, the "Corporation").

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation shall be 2902 59th Street West, Suite H, Bradenton, Florida 34209.

ARTICLE III

PURPOSES

The Corporation shall be organized for the specific purpose of the operation of an oral and maxillofacial surgery practice. In addition, the Corporation shall have the power to transact any business in connection with the aforementioned purpose and not prohibited by law.

ARTICLE IV

AUTHORIZED CAPITAL

The aggregate number of shares which the Corporation shall have authority to issue is one thousand (1,000) shares of common stock with no par value.

ARTICLE V

INITIAL OFFICERS & DIRECTORS

The Corporation shall initially have one (1) Director, who shall also initially serve as the President, Secretary and Treasurer. The name and address of the initial Director, President, Secretary and Treasurer are:

ARTICLE VI

DISSOLUTION

Upon the dissolution of the Corporation, the Board of Directors shall, after a majority vote of the then current directors, adopt a plan of distribution of the assets of the Corporation and the same shall be filed with the Department of State. Such plan of distribution of assets shall provide for the payment or make provision for the payment of all liabilities of the Corporation and convey any remaining assets of the Corporation to David Christian. Any such assets not so disposed of shall be disposed of in a manner consistent with the provisions of Section 607.1405 of the Florida Statutes, as it exists on the date hereof, or as amended.

ARTICLE VII

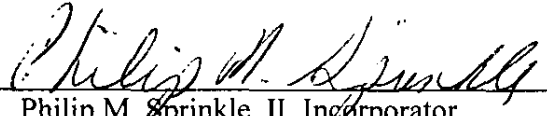
REGISTERED AGENT AND REGISTERED OFFICE
