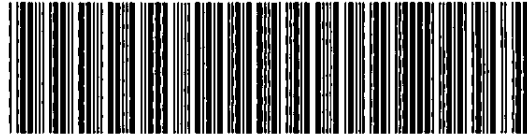



1. Introduction. Dennis Fouts, being duly sworn, deposes and says:


