

ARTICLES OF INCORPORATION OF TOWN OF HIALEAH 24, INC.

ARTICLE I. CORPORATE NAME.

The name of this corporation is: TOWN OF HIALEAH 24, INC.

Corporate Address: 8200 SW 130TH STREET, MIAMI, FLORIDA 33158

ARTICLE II. NATURE OF BUSINESS.

The specific nature of the business of this professional association shall be the general practice of law as permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE III. DURATION.

This corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is:

ARTICLE IV. CAPITAL STOCK.

This corporation is authorized to issue shares of stock as follows:

- A. Designation: The stock of this corporation shall be known as Common Stock.
- B. <u>Authorized:</u> The maximum number of shares of Common Stock that this corporation may issue is: 100.

- G. <u>Dividends:</u> Record holders of Common Stock are entitled to receive their pro-rate share of any

dividends that may be declared by the Board of Directors out of assets legally available for such purpose.

H. <u>Liquidation Rights:</u> Holders of Common Stock are entitled, in the event of liquidation or dissolution of this corporation, to receive their pro-rate share of any assets of this corporation remaining after payment of all corporate debts and obligations.
