ARTICLE IV - INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT

All actions which the Florida Business Corporation Act reserves to the Board of Directors are hereby reserved to the shareholders, including, without limitation, the adoption of the initial bylaws of the corporation, the issuance of any emergency bylaws of the corporation; the issuance of stock; is reserved to the shareholders.
