### ARTICLES OF INCORPORATION

### **Business Writer Inc.**

The undersigned, for the purposes of incorporating a corporation under the Florida Business Corporation Act, does hereby execute those Articles of Incorporation and does hereby certify as follows:

FIRST: The name of the corporation (hereinafter called the "Corporation") is Business Writer Inc. The principal place of business is 3399 PGA Blvd. #300, Palm Beach Gardens, Florida 33410.

SECOND: The address of the registered office of the Corporation in the State of Florida is 3399 PGA Blvd. #300, Palm Beach Gardens, Palm Beach County, Florida 33410 and the name of the registered agent of the Corporation in the State of Florida at such address is Mark H. Mirkin.

<u>THIRD</u>: The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

<u>FOURTH</u>: The Corporation is authorized to issue one million (1,000,000) shares of Common Stock with a par value of \$0.01 per share.

Neither any amendment nor repeal of this Article EIGHTH, nor the adoption of any provision of these Articles of Incorporation inconsistent with this Article EIGHTH, shall eliminate or reduce the effect of this Article EIGHTH in respect of any matter occurring, or any cause

of action, suit or claim that, but for this Article EIGHTH, would accrue or arise, prior to such amendment, repeal or adoption of an inconsistent provision.

NINTH: The Corporation shall, to the fullest extent permitted by the Florida Business Corporation Act as amended from time to time, indemnify all persons whom it may indemnify pursuant thereto.

<u>TENTH</u>: The incorporator of the Corporation is Mark H. Mirkin, whose mailing address is 3399 PGA Blvd. #300, Palm Beach Gardens, Florida 33410.
