To lend money to, and use its credit to assist, its officers and employees in accordance with Florida Statute S607.141;

To purchase, take. Receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, Sell, mortgage, lend, ledge or otherwise dispose of and otherwise use and deal in and with.

Shares or other interest in, or obligations of, other domestic or foreign corporations, associations, partnerships or individuals or direct or indirect obligations of the United States or of any other government, state, territory, governmental district or municipality or of any instrumentally thereof;

To be a promoter, incorporator, partner, member, associate or manager of any corporation, partnership, joint venture, trust or other enterprise.


#### ARTICLE IV


