The Board of Directors and Shareholders of the Corporation shall be composed by two (2) person, as follows:

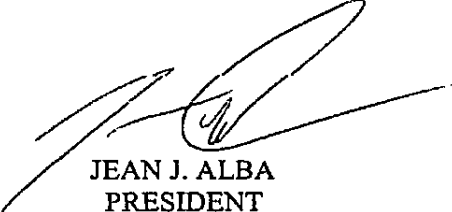
