ARTICLES OF INCORPORATION

FIRST: The Articles of Incorporation of DELTA INTER FL CORP. were filed with the Florida Department of State on June 6, 2012, document number P12000045712.

SECOND: The Articles of Incorporation of DELTA INTER FL CORP. are hereby amended and restated in their entirety to read as follows:

ARTICLE I  
NAME

The name of the corporation is DELTA INTER FL CORP. (hereinafter, the "Corporation").

ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS

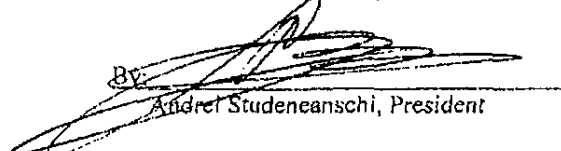
ARTICLE III
