ARTICLES OF INCORPORATION OF VB LAUNDRY, INC.

The undersigned incorporator, for the purpose of forming a corporation under Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation.

Article 1. The name of the Corporation is:

VB LAUNDRY, INC.

Article 2. The Corporation is formed for the following purposes: operation of a laundry and all other operations permitted by law.
