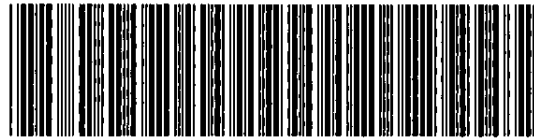

ARTICLES OF INCORPORATION
OF
MOYLE LAW FIRM, P.A.

The undersigned hereby establishes the following for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a Corporation for profit.

ARTICLE I
Name of Corporation

The name of this Corporation shall be Moyle Law Firm, P.A. (the "Corporation"). The Corporation shall be a Subchapter "S" Corporation pursuant to the Internal Revenue Code.

ARTICLE II

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

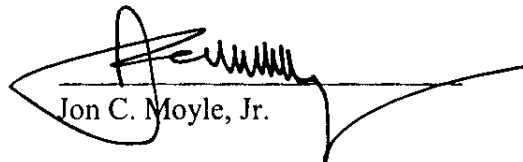
