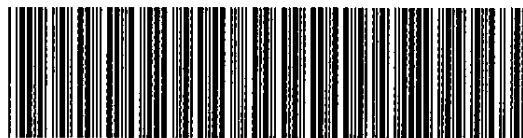

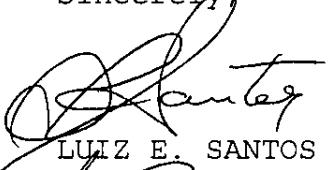

OF

ARTICLE I. NAME

The name of this corporation is
NENEM'S VITAMINS & NUTRITION, INC.

This corporation shall have perpetual existence.

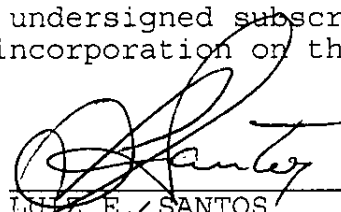

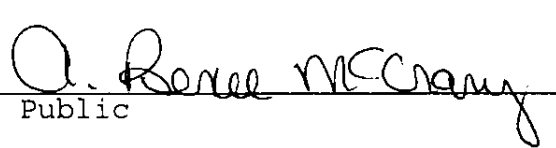
