This Corporation shall have perpetual existence commencing effective within five working days of the date of receipt of these ARTICLES OF INCORPORATION.

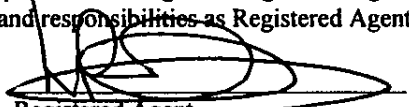

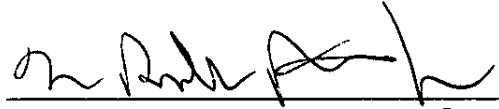

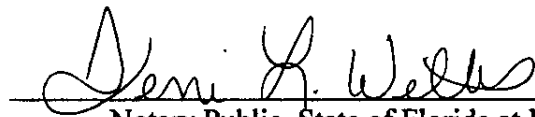
