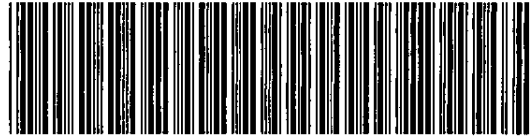

The name of the corporation shall be: LAW OFFICES OF THOMAS D. SOMMERVILLE, P.A.

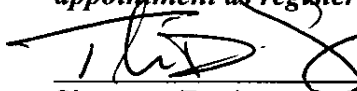

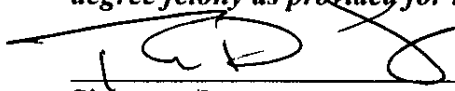
