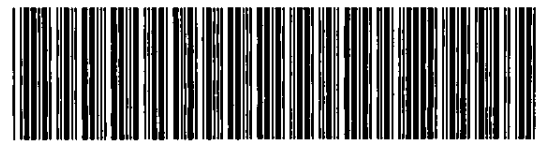



ARTICLE IV - ADOPTION OF DISSOLUTION


