laws of the State of Florida.

ARTICLE I
(name)

1.01 The name of the Corporation is STEADY STEAM TRUCKING, INC.

(Nature of Business)

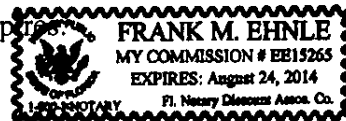

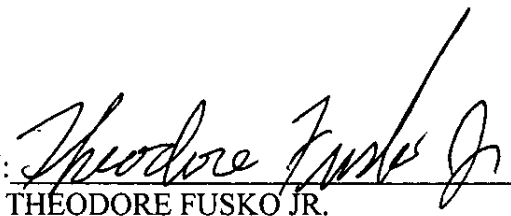
