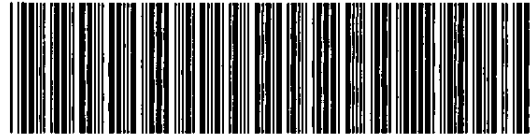



**ARTICLES OF INCORPORATION
OF
LOVETTO DESIGN, INC.**

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act, Florida Statutes, Section 607, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is: **LOVETTO DESIGN, INC.**

ARTICLE II - DURATION

The existence of this corporation shall commence with the filing of these articles. The term of existence of this corporation is perpetual.

ARTICLE III - PURPOSE

The specific nature of business is to engage in the business of interior design, and to transact any or all other lawful business for which a corporation may be incorporated under the Florida laws.
