## **Articles of Incorporation Of**

**Opportunity Homes Inc.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

### **Article I Name**

The name of the corporation shall be:

### **Article II Nature of Business**

The corporation shall have the powers to engage in any lawful activity for which corporations may be organized under the Florida Business Corporation Act.

### **Article III Mailing Address**

**Capital stock**

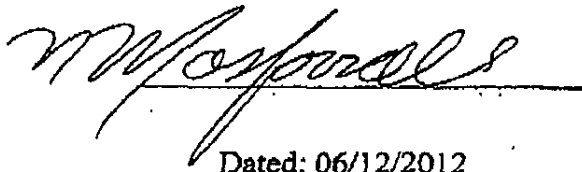
