

ARTICLES OF INCORPORATION

In compliance with Chapter 607 and Chapter 621, Florida Statutes 12 JUN 11 PM 2:33

ARTICLE I NAME

The name of the corporation shall be: Kelly C. Culbertson, P.A.

ARTICLE II PRINCIPAL OFFICE

The street & mailing address of the initial principal office of the corporation is: 930 46th Avenue North, St. Petersburg, FL 33703.

ARTICLE III PURPOSE

This corporation is organized for the purpose of providing legal services and advice, and for the purpose of the transaction of any or all related lawful actions for which such corporations may be incorporated under Florida Statutes, Chapters 607 and 621.

ARTICLE IV SHARES

This corporation is authorized to issue 100 shares of \$1.00 par value common stock. The subscription of said stock shall be paid for in lawful money of the United States of America, or in other property, exclusive of stock or securities. In the event that any such property exchanged for stock has no easily certifiable value, such valuation shall be fixed by the Board of Directors at the regular or special meeting called for that purpose.
