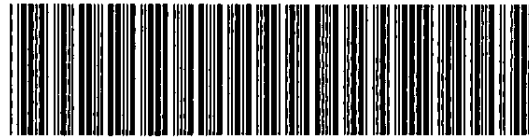

## Island Charters of Capri, Inc.
