ARTICLE I – NAME





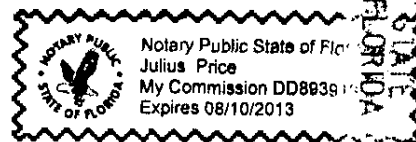
