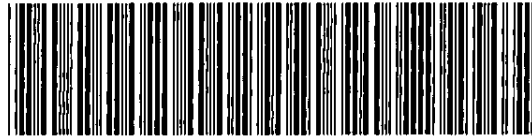

**Article I
Name**

The name of this corporation is US INTERNATIONAL DISCOVERY BAND & ARTIST IDOL, INC.

**Article II
Principal Office Address**




