Under Section 807 of the Business Corporation Law

FIRST: The name of the Corporation is AVIACOL USA, CORP (the "Corporation").

SECOND: The Certificate of Incorporation of the Corporation was filed by the Department of State on June 19, 2012.

THIRD: The Certificate of Incorporation of the Corporation is hereby amended or changed to effect one or more of the amendments or changes authorized by the Business Corporations Law, to wit:
