ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of **Apollo Ship Chandlers No. 8, Inc.**, a Florida corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is **Apollo Ship Chandlers No. 8, Inc.**

SECOND: The Articles of Incorporation of the Corporation are hereby amended by deleting the entire Article I as it now exists and inserting in lieu thereof a new Article I, reading as follows:

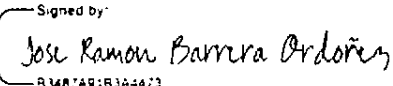
"ARTICLE I. NAME
