**ARTICLES OF AMENDMENT
(NAME CHANGE)
TO THE
ARTICLES OF INCORPORATION
OF
MAF BANNERS, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, **MAF Banners, Inc.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

Article I of the Articles of Incorporation of the Corporation shall be amended in its entirety to read as follows:

ARTICLE I

Name

The name of the Corporation is Sherloq Banner Solutions, Inc.

Date and Manner of Adoption

The Corporation has 35 or fewer Shareholders. This amendment was adopted by the Corporation's Shareholders on January 29, 2013, at a meeting of Shareholders at which a quorum was present and the number of votes cast by the Shareholders was sufficient for approval of the Amendment.
