(NAME CHANGE)
TO THE
ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, **Fitness Financial Services, Inc.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

Article I of the Articles of Incorporation of the Corporation shall be amended in its entirety to read as follows:

ARTICLE I

Date and Manner of Adoption
