
I didn't receive that letter. I've had a lot of problems with the mail to Team Cup since I closed or perhaps I should say when I stopped doing business mid December 2015.

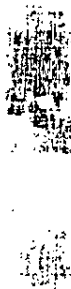
