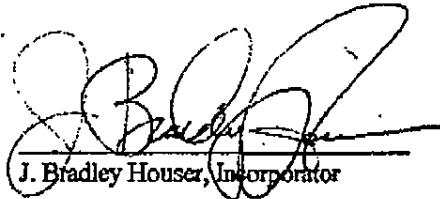
ARTICLE IX

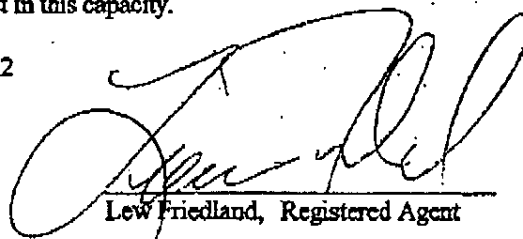
