The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is ST MATH, INC. and its principal office and mailing address is: 2309 South MacDill Avenue, Tampa, Florida 33629.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on the date of acknowledgment of the Articles of Incorporation by the Florida Secretary of State.
