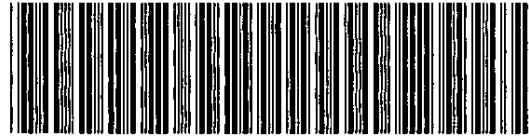

**FIRST:** Amendment(s) adopted:


Article I, Corporation Name
