The undersigned incorporator to these Articles of incorporation hereby form a corporation under the laws of the state of Florida as follows:

ARTICLE I

Term of Existence

This Corporation shall have perpetual existence, commencing upon filling of these articles of incorporation with the Florida Secretary of State.

ARTICLE III

Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV

Powers

The Corporation shall have the power:

- a. To have perpetual succession by its corporate name.

- e. To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or part of its property and assets.
- f. To lend money to and use its credit to assist its officers and employees to the full extent permitted by law.
- g. To purchase, take, receive, subscribe for, or otherwise acquire, own hold, vote, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations,

partnerships or individuals, or direct or indirect obligations of the United States or any other government direct, or municipality or of any instrumentality thereof.

- h. To make contracts and guaranties and incur liabilities, borrow money at such rates of interest as the Corporation, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchise, and income.
- i. To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
