### **VANHOOF CONSTRUCTION COMPANY**

BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

- I. NAME. The name of the corporation shall be VANHOOF CONSTRUCTION COMPANY
- II. TERM. This corporation shall exist perpetually.




