Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment adopted:

A) Article III. CAPITAL STOCK is hereby amended as follows:

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is one hundred (100) shares of common stock having a nominal or par value of \$1.00 per share. None of the shares of the Corporation may be issued to anyone other than an individual who is duly licensed medical doctor in the State of Florida and is an active member of the State of Florida Department of Business and Professional Regulation and is in good standing with the State of Florida Department of Business and Professional Regulation.

SECOND: The date of the adoption of the aforementioned amendments is July 26, 2012.

THIRD: Adoption of Amendment

The amendment was approved by the shareholders. The number of votes cast for the amendment was sufficient for approval.
