ARTICLES OF INCORPORATION

OF

<u>ARTICLE I - NAME</u>

The name of the corporation is Borca Enterprises, Inc., at 2705 Ranch Road, Melbourne, FL 32904 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
