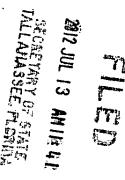

ARTICLES OF INCORPORATION

OF

ALYSSA HAYLIE ENTERPRISES, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

Name: The name of the corporation shall be: ALYSSA HAYLIE ENTERPRISE

ARTICLE II

<u>Principal Office:</u> The principal street address and mailing address is: 1900 Okeechobee Boulevard, West Palm Beach, Florida 33409.

ARTICLE III

<u>Purpose</u>: The purpose for which the corporation is organized is to have and exercise any and all powers necessary or convenient to effect its purpose and to otherwise engage in any lawful business permitted under the laws of the State of Florida.

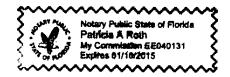
