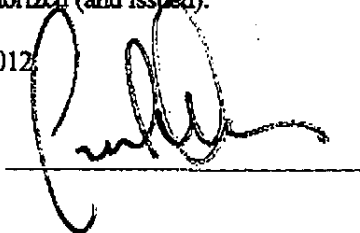
## ARTICLE SEVEN
