

The undersigned, for the purpose of forming a for-profit corporation under the laws of the state of Florida, do hereby adopt the following Articles of Incorporation:

**ARTICLE I**  
**[NAME]**

The name of the corporation shall be **Tasha Lester Consulting, Inc.** (hereinafter called the "Corporation").

**ARTICLE II**  
**[PRINCIPAL OFFICE AND MAILING ADDRESS]**

**ARTICLE III**  
**[PURPOSE]**


