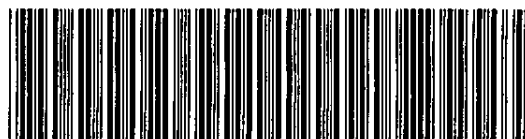



**ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: ANDERSON ENTERPRISES OF NORTHWEST FLORIDA, INC.

ARTICLE II

The street address of the principal office of the Corporation is: 95 Kenneth Harrison Road, Ponce De Leon, Florida 32455.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 100, all of which shall be Common Shares. The Corporation is authorized to issue only one class of stock, and all issued stock shall be held of record of not more than ten persons. Stock will be issued and transferred to: (1) natural persons; (2) estates, or (3) a trust as described in title 26 United States Code Section 1371, defining a qualified "small business corporation." In addition, no stock shall be issued or transferred to a nonresident alien.

ARTICLE IV

ARTICLE V






